RustRadio broadcasts in house only and does not rely on external relays, Although RustRadio is listed on a number of external sites all audio feeds will connect directly to RustRadio's stream server.

Terms and Conditions.

I. USE OF WEBSITE

This website ("Site"), is a website owned and operated by RustRadio,

("RustRadio", "we", and "us").

These terms of use ("Terms of Use") (together with the documents referred to herein) set out the terms on which you may use our Site and the radio player accessible via our Site or one of our apps (the "Radio Player"), whether as a guest or as a registered user. Please read these Terms of Use carefully before you start to use the Site or Radio Player. By using or accessing our Site or Radio Player (whether you access the Site or Radio Player on your computer or on a handheld mobile device), you indicate that you accept these Terms of Use and that you agree to abide by them.
