RustRadio broadcasts in house only and does not rely on external relays, Although RustRadio is listed on a number of external sites all audio feeds will connect directly to RustRadio's stream server.

Privacy Policy

1. RustRadio has a legal duty to protect any information we collect from you. It will not be disclosed to any other organisation unless you give explicit permission, or there is a legal obligation to do so.

2. RustRadio does not collect or store information regarding listeners information.

3. RustRadio only stores information that has been given with consent

Cookies

Cookies are used to tailor your experience on our website. Our Cookies include language preference and information to pass reCAPTCHA validation on the contact forum.

Cookies are small pieces of information that are stored by your browser on your computer's hard drive.

When someone visits our website we use a third-party service, Google Analytics, to collect standard internet log information and details of visitor behaviour patterns. We do this to find out things such as number of visitors to the various parts of the site. This information is only processed in a way which does not identify anyone. We do not make, and do not allow Google to make any attempt to find out the identities of those visiting our website.
